New License Must Be Displayed By JUNE 30th

Dear Tinley Park Resident,

Enclosed is your 2017-2018 vehicle sticker application. Vehicle stickers are available for purchase on April 1, 2017. Per Sections 71.04 through 71.09 of the Tinley Park Municipal Code, any motor vehicle operated by a resident on a public street or highway within the Village of Tinley Park (including any motor vehicle that is not in use but which is kept or stored within the Village) requires a vehicle sticker. Leased and company owned vehicles are included. Vehicle stickers are valid from May 1, 2017 through April 30, 2018.

Residents must purchase a vehicle sticker within 30 days of moving into Tinley Park or within 30 days of purchasing a new vehicle (proof of move-in date or proof of vehicle purchase must be provided to the Village at time of sticker purchase). Residents 65 years of age or older within the **CALENDAR** year are eligible for the senior citizen fee on passenger vehicles only upon presentation of a current driver's license (1 per driver's license, trucks not included).

Please examine the preprinted vehicle information on this application and update as required. Missing information and/or corrections should be placed in the appropriate spaces. **All** information must be completed. If you have sold a vehicle and have not replaced it, simply mark "SOLD" in the fee section for that vehicle and return.

Upon completion of **BOTH** sections of this form by mail (mail must be sent to the Village Hall) or in person with cash, check or money order made payable to the Village of Tinley Park, you will receive your sticker. Credit card payments (Discover, MasterCard, Visa) are accepted **IN PERSON** at the Village Hall and Police Department. A drop box is available outside the Village Hall, if paid by mail or drop box, your sticker will be returned to you via mail.

Leased and company owned vehicles are included. Vehicle Stickers are valid from May 1, 2017 through April 30, 2018.
